Judo Gi's: A White judo gi is mandatory for all participants

A blue judo gi may be used only when playing on the blue side. Please bring your own blue & white belts.

Referee and Table Staff Training: Thanks to those of you that come out and volunteer your time to help AZ Judo tournaments! Together we make a difference.

Eligibility: Proof of current membership in USJA, USJF or US Judo is mandatory and must be presented and verified at registration. Foreign players must show current membership in their country's recognized national judo federation. There is no Arizona state residency requirement, it is open to all.

Divisions: All divisions are determined at the time of weigh-ins and are subject to modifications based on entries. We will make every attempt to keep the Junior divisions within one to two years apart. We will then subdivide them into a minimum of a light, medium and heavy category. All decisions by the Tournament Director are final.

Categories:

- 1) Junior Novice
- 2) Regular Junior
- 3) Senior Novice
- 4) Regular Senior
- 5) Masters

Junior Novice is defined as a player who holds the rank of yellow belt or below. Adult Novice is defined as a player who holds a rank of Yonkyu or below and less than 1 year of experience. Masters division is defined as a player over 30 years of age at any rank.

Rules: All matches will be conducted using the current 2019 IJF/USA approved rules with the following modifications:

1. **No armlocks** in [A] any junior divisions, [B] senior novice divisions
2. **No chokes** in [A] any junior novice divisions or [B] regular junior divisions younger than 13-years old.

## WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from in any Judo tournament, practice, clinic, and related events and activities ("Activity") of the **United States Judo Association, Inc., United States Judo Federation, Inc., and USA Judo/United States Judo, Inc.**, I agree and affirm that:

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.
2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.
5. I hereby release, waive, discharge and covenant not to sue the **United States Judo Association, Inc., United States Judo Federation, Inc., and USA Judo/United States Judo, Inc.**, together with their affiliated clubs, their respective administrators, directors, officers, agents, coaches, and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, legal guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used in conducting the event, all of whom are hereinafter referred to as "Releasees", from any and all litigation expenses, attorney fees, loss, liability, damage or costs on account of injury, illness, disease, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by the negligent acts or omissions of the Releasees or otherwise to the fullest extent permitted by law.
