Waiver and Release of Liability Agreement

- (1) I, the applicant, acknowledge and fully understand that I will be engaging in a contact sport and agree that I know the risks involved in the sport of judo and assume these risks and responsibilities for any damages and/or injuries resulting from my engaging in the contact sport of judo, including any complications resulting from any health or medical conditions that I have. In executing this waiver, I understand Toshi Dojo's condition that I must obtain the consent of my physician in order to participate if I have known, serious medical conditions. I further agree to release and discharge, Toshi Dojo, its instructors, coaches, officers, members, other participants, their parent(s) or legal guardian(s), the owners, lessors, and lessees of the premises used to conduct judo training from or for all claims, demands and causes of actions or any other liabilities which arise by virtue of injuries or damages caused in connection with or arising out of membership with Toshi Dojo or participating in judo training conducted by Toshi Dojo, and the action or lack thereof of the above parties.
- (2) Parent(s) or legal guardian(s) of minor participants(s) additionally agree to instruct the minor participant(s) to the above conditions and warnings. Furthermore, a parent or legal guardian's execution of this Waiver and Release evidences that individual's express consent to the minor's participation with full understanding of Paragraph (1), and agrees the child and any representative for the child are bound by the language of Paragraph (1).
- (3) I have read the above warning, waiver and release, and understand that I give up substantial rights by signing it, and do so voluntarily. Additionally, I agree to abide by Toshi Dojo's Rules and Regulations on the reverse side of this Waiver and Release.

Rules and Regulations

Signed waiver is required of all participants. Signature of parent or legal guardian is required for all minor participants under 18 years of age.

The personal hygiene standard of all participants shall be of a reasonable standard. Participants shall keep all nails trimmed short.

Long hair should be tied so that it does not interfere with judo training.

The judo uniform should fit properly, be in good condition (free of tears etc.), be generally clean and dry and without unpleasant odor.

Participants are to take into consideration their age, physical condition, medical problems/injuries and experience level and exercise due caution for their own safety and the safety of other participants.

Prior to participating, participants are responsible for inspecting the mats, equipment and facilities, and if they feel anything is unsafe, they are to bring it to the attention of the person in charge. They should refuse to participate unless the unsafe condition is corrected.

The wearing of jewelry or any hard-metallic object is prohibited.

Courtesy, good manners and good sportsmanship is required.

The instructions of the coach or teacher are to be followed by all participants.

National organization membership is required participate (USJA, USA JUDO, USJF)

Individuals who are under, or appear to be under the influence of alcohol or drugs will not be allowed to participate.

Individuals who are infected with a highly contagious disease which could pose a serious health threat to other participants are prohibited from entering the premises. Individuals who fit into this category have the responsibility to inform the tournament director.

Participants or non-participants who violate above rules, depending on the frequency and severity, are subject to suspension or dismissal from the event.

Participants must be on time for the start. Late arrival may result in loss of entry. No refunds!

Some type of footwear has to be worn when off of the mat. When a participant leaves the mat to use the restroom, footwear must be worn.

During Junior Classes parents or legal guardians are required to stay mat side, for ages eight and under.

There will be no refunds.
