This form has instructions for completion and lists all current requirements and fees related to a validation recommendation. The candidate will complete this form. The examiner(s) will recommend the candidate for the rank they believe the candidate is qualified to hold. Candidate is responsible for sending completed forms, all required substantiating documentation, processing and validation fees to the USJA National Office for processing. All forms and documentation must be typed.

Validation of jujitsu rank is only for those that lack acceptable credentials of valid jujitsu rank issued by an organization acceptable to USJA.

A person can be validated only once. That becomes the date of their valid rank, from which time in grade starts toward their next promotion within USJA.

The candidate must demonstrate the requirements in effect to the highest rank possible. See Jujitsu Test for requirements for each rank. As an example: A candidate for shodan should perform techniques as if defending an attack, counter initial attack, and then a suitable control over attacker. Basic requirements such as simple wrist releases need not be shown as individual techniques. Rather they should be part of the overall defense, counter, and control demonstrated by candidate against each attack.

Validation Testing by Certified Rank Examiner (CRE): The primary means of conducting validation testing is with the use of a CRE. If you do not know a CRE contact the USJA office or any Jujitsu CRE committee member to arrange for testing with a CRE. It is up to the candidate to cover any expenses incurred with having a CRE conduct your validation testing.

Video: If it is not feasible, and with Jujitsu Promotion Board approval, an online video may be submitted in lieu of live testing with a CRE. This video should include, as a minimum, all the techniques required to the highest rank the candidate can successfully complete. Provide internet address for viewing video.

Upon receipt of the required information and validation form with associated paperwork, the USJA National Office will confirm that membership, background screen, Heads Up and SafeSport certifications are valid and forward all documentation to the Jujitsu Promotion Board for review and final approval. Once approved, a new membership card and rank certificate will be issued.

Training and Study: When requesting validation, remember this requires documentation of many years of studying Jujitsu. Study and practice time must be equivalent to the time one would have spent going through each rank up to the recommended rank. As an example, if you have been studying/practicing jujitsu for two (2) years you can't expect validation to Nidan, which requires five (5) + years of study/practice. With two (2) years of study/practice, you would be validated no higher than 2nd kyu.

Attach a detailed list of your jujitsu related training, studying, clinic and camp attendance, all jujitsu clubs you have been a member of - including dates, head instructor and their contact information.

Prerequisites for Validation: All candidates for dan validation must complete the following: current background check, SafeSport and Heads Up certification.

Validation Fees: All validations require a \$35 processing fee when validation request is submitted. Once validation is approved by USJA jujitsu promotion board, the following fees are due.
